### PANEL #3: ENSURE INFORMED, COORDINATED, AND EXPEDIENT RESPONSES

**Issue Areas Identified:** Moving collections out of the path of the disaster; communication among organizations; models for response; information about Incident Command System; identifying qualified volunteers; stockpiling supplies; importance of training for and timing of response; challenge of insufficient infrastructure.

**Projects:** Recommend essential training for cultural responders; include the Task Force in the ESF #11 Annex of the National Response Plan; create a guide for establishing mutual assistance networks; develop and test GIS data standards for archives, libraries, and museums; establish a national listing of cultural responders.
